REGULATION

of student's activity in department of pharmacology and clinical pharmacology.

Teaching process in the department should not disturb the normal activity of health-workers in the department and should not produce some risk or harm for patient's health. It is our common responsibility to protect the patients from any risks, complications or psychological stress.

The student is obliged to:

- 1. Participate in all classes and lectures. A student must be in time, the teacher will not wait for the delayed students, and they will be noted as absent.
- 2. Leave all your personal items, bags and other in the cloakroom.
- 3. To be equipped as required (white coat, in clinics: overshoes, fasces work etc.). White coat should be absolutely clean and ironed.
- 4. No foods or drinks allowed in the Department.
- 5. Mobile phones are not allowed during the lesson (even in the silent profile). Turn your phone off entering the department.
- 6. Speak as quietly as possible! The noise disturbs medical personnel and very uncomfortable for patients.
- 7. Do not discuss any issues in the patient room.
- 8. No photo! You may not make any pictures in the department, and.
- 9. In clinics: Always ask patient's permission before start any type of medical examination.
- 10. Smoking is strongly prohibited.
- 11. To evade or use monsters for demonstration drugs;
- 12. The access of students to the offices of the staff of the department is prohibited.
- 13. The student should not disturb the doctor outside of class hours, recovery and consultation hours.
- 14. Demonstrate respect for the University property.
- 15. Not to apply so much perfume or other aromatic oils, before the lessons as it's found an irritant, giving the headache, or allergy.
- 16. To keep a good standard of personal hygiene.
- 17. Pass all test controls within the period of time stipulated and enroll for a given year.
- 18. The department shall expel a student if the student violates the canons of ethics and deontology.

Remember! Incompliance with above mentioned rules will result in your <u>exclusion from practical lesson</u>. Any type of intentional or unintentional harm caused to patients and to the stuff represents a legal issue and <u>may be punished</u> according to the University Regulations and Laws of Republic of Moldova.
